



Booking Terms and Conditions

Booking

Once TM Fisheries receives your completed booking form and deposit, your holiday will be reserved for you and your party. Your booking is considered confirmed and accepted for all individuals in your group when we issue an invoice to the person who signed the booking form. By sending the booking form, the signer confirms they have the authority to make the reservation on behalf of everyone included and that they have read and accepted these Booking Terms and Conditions, as well as the Fishery Rules and Restrictions. Deposits are accepted under the strict understanding that this condition has been met.

Deposit

A non-refundable deposit of £100 per angler or £1000 for exclusive lake bookings must accompany your booking form. Payments are accepted via bank transfer. Please request our bank account details when making your reservation. If applicable, fees for Non-Fishing Guests (£70 per person) will be collected with the balance payment.

Balance of Payment

The balance of your payment is due no later than 10 weeks before your scheduled arrival date. If you book within 12 weeks of your arrival, the total holiday cost must be paid at the time of booking. Failure to pay in full 10 weeks prior to your arrival will result in TM Fisheries canceling your booking and charging a cancellation fee as outlined in paragraph 4.

Cancellation

Cancellations must be made in writing and signed by the Group Organiser. The following fees apply:

- Cancellations up to 10 weeks before your travel date: deposits paid.
- Cancellations less than 10 weeks before your travel date: the full cost of the holiday.
- We reserve the right to apply an administration charge, depending on the circumstances.

Booking Changes

We strive to accommodate booking changes wherever possible. Please get in touch if you need to modify your reservation.

Travel Documents

All guests must ensure they have the necessary passport and travel documents. We strongly advise having a valid EHIC and travel insurance. TM Fisheries accepts no responsibility for any issues with travel documents.

Travel Arrangements

Guests are responsible for their travel arrangements. TM Fisheries is not liable for delays, cancellations, or disruptions, including border closures or quarantine measures.

Children

The fishery is not suitable for children under 12. All children aged 12 to 18 must be supervised by a responsible adult at all times.

Pets

Pets are not allowed.

Fishery Rules and Regulations

All guests at Etang des Moulinots, including anglers and non-anglers, must agree to abide by the fishery rules set by management.

Jurisdiction

Signing the booking form creates a contract under French law, with the exclusive jurisdiction of the French Courts.

Force Majeure

TM Fisheries is not liable for loss or delays caused by events beyond our control, including but not limited to strikes, political unrest, port closures, industrial disputes, natural disasters, pandemics, or other force majeure events.

TM Fisheries reserves the right to terminate services if we or our appointed representatives deem your behavior to cause discomfort or harm to others, the fish, property, or the environment. In such cases, no refunds or compensation will be provided, and you may be liable for damage costs.
